## **Before You Sign or Pay Recommendations and Links**

Before you sign a contract or start home repairs/renovations, read this. All homeowners should follow the following recommendations when hiring a contractor:

- Always require a written estimate, signed by a contractor before any work begins.
- Get written estimates from several contractors. Make sure bids are based on the same project details.
- Check out the contractor with your local or Florida consumer protection officials.
- Ask the contractor for customer references who have projects similar to yours.
- Ask for a copy of the contractor's current insurance certificates and licenses, if licenses are required
- Get all guarantees, warranties and promises in writing. Always remember that old saying: "if it isn't in writing, it didn't happen."
- Agree on start and completion dates, and have them written into the contract.
- Never pay money up front for deposits without a written and signed contract.
- Report suspicious contractor behavior to the Better Business Bureau and local law enforcement.
- Never pay for work that is not completed to your satisfaction.
- Florida has very strict lien laws that can either help you or harm you.
  Always require a signed acknowledgment of payment in full and a
  release of all liens. If materials are supplied by a different company or
  laborers are provided by a different company, be sure you get lien
  releases from them as well. Require that your contractor prove
  payment of all material suppliers and workers.
